CORRECTIVE AMENDMENT TO THE DECLARATION OF CONDOMINIUM FOR

WHEREAS, the Developer wishes to amend said Declaration for the purpose of correcting a Surveyors Certificate of Substantial Completion recorded on February 4, 1993 at Official Records Book 1794, Pages 547 through 550. The Surveyors Certificate of Substantial Completion contained an error in the name of the Condominium. The name of the Condominium should read "BERMUDA GREENS, A CONDOMINIUM, PHASE 2, and not BERMUDA GREENS II, A CONDOMINIUM.

NOW, THEREFORE, the Developer hereby corrects Page 35 of Exhibit "B", SURVEYORS CERTIFICATE OF SUBSTANTIAL COMPLETION by inserting a new Page 35 of Exhibit "B", to reflect substantial completion of Building C.




