CERTIFICATE OF AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR BERMUDA GREENS COMMONS

THIS AMENDMENT, made this 29th day of March, 1995, by BERMUDA GREENS COMMONS ASSOCIATION, INC., a Florida Not-for-Profit Corporation (the "Association").

WHEREAS, a Declaration of Covenants, Conditions and Restrictions for BERMUDA GREENS COMMONS was recorded in Official Records Book 1662, Pages 1186 through 1247, inclusive, as amended, of the Public Records of Collier County, Florida; and

WHEREAS, Section 13 of said Declaration provides for methods of amending the Declaration and its exhibits. In addition, Section 10 of the Bylaws of the Association provide that amendments to the Bylaws may be made by the concurrence of at least 2/3 of the Directors at any meeting called for that purpose (which Bylaws are attached as an Exhibit to said Declaration).

WHEREAS, the appropriate approvals have been obtained so as to amend the Bylaws.

WHEREAS, the Association wishes to amend said Declaration for the purpose of changing the number of Directors from three to live.

NOW THEREFORE, as the Association has received approval of the requisite 60% of the membership of the Association, the Association hereby amends the aforesaid Declaration by revoking Section 4.1 of the Bylaws (Exhibit "D" to the Declaration) and by inserting in lieu thereof:

4.1 <u>Number and Terms of Service</u>. The Corporation shall be governed by a Board of Directors initially consisting of three (3) five (5) Directors. The Directors of the Corporation shall have a fiduciary relationship to the members.
