**CERTIFICATE OF AMENDMENT

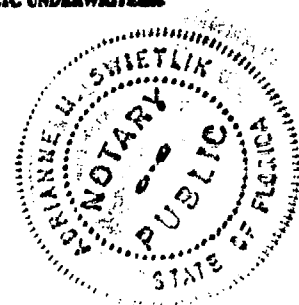
