CERTIFICATE OF
AMENDMENT TO DECLARATION OF CONDOMINIUM

OF

BERMUDA GREENS, A CONDOMINIUM

The undersigned being the Developer of BERMUDA GREENS, a Condominium, according to Declaration of Condominium recorded at O.R. Book 1662, Pages 1248 et. seq., Public Records of Collier County, Florida; (hereinafter the "Declaration"), hereby amends said Declaration pursuant to Section 718.403(6) of the Florida Condominium Act, for the purpose of adding Phase IV to the Condominium.

Note: New language is underlined; language being deleted is shown in struck through type.

Section 2 of the Declaration is hereby amended as follows:

2. SUBMISSION STATEMENT. The Developer at this time hereby submits only those portions of the Land described on Pages 4, 5, and 6 and 7 of Exhibit "A" as Phases 1, 2, and 3 and 4, and appurtenances belonging thereto, and all other property, real, personal or mixed, located on and intended for use in connection therewith, to the condominium form of ownership and use in the manner provided by the Florida Condominium Act as it exists on the date of recording this Declaration; excluding therefrom, however, all public utility installations, cable television lines, and other similar equipment, if any, owned by the utility furnishing services to the Condominium.

The number of units being added to the Condominium by this Amendment is Thirty-two (32). The identification numbers of each unit are set forth on Page 2 of Exhibit "B" to the Declaration. In addition, Page 1 of Exhibit "B" of the Declaration contains a survey of the additional land being added and the plot plans as required by Section 718.104(4)(e) of the Condominium Act. The undivided share of ownership of the common elements and common surplus appurtenant to each unit, as well as each unit's share of the common expenses, is set forth in Section 6.2 of the Declaration.

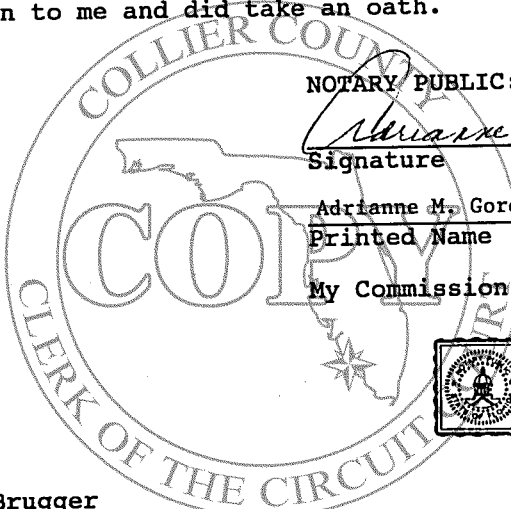
