**CERTIFICATE OF AMENDMENT

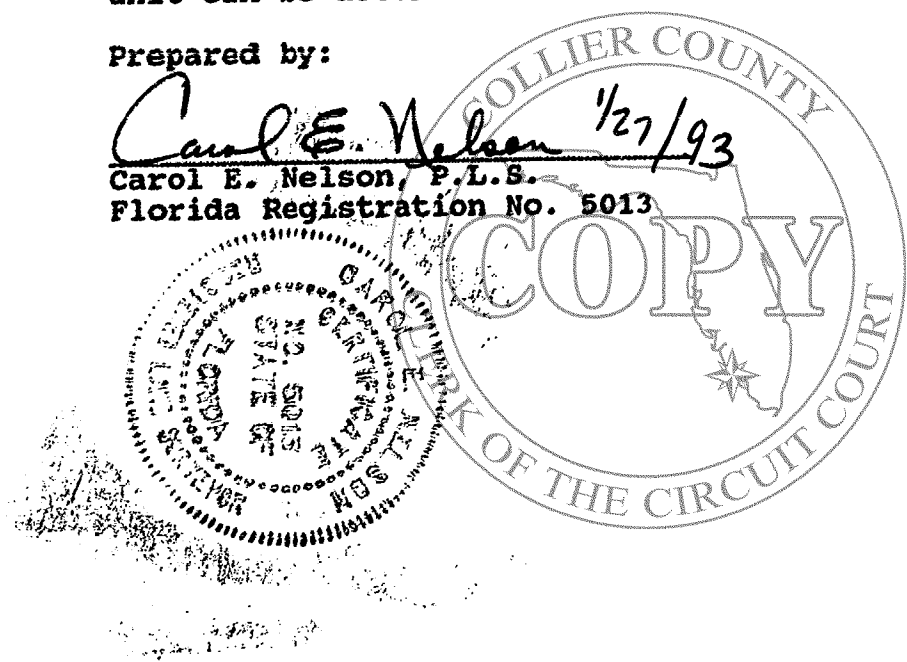
CERTIFICATE OF SURVEYOR made this 22st day of January, 1993.
