To provide all labor, materials, equipment, insurance, and supervision to complete the scope of work as follows to build one new recessed bocce ball court size 12' x 60'

1. We will remove old bocce ball court.
2. We will create a sub base with lime rock screenings using our laser guided equipment to create the proper slope for drainage with a minimum compaction of 95%..
3. 2x8 Brazilian hardwood will be used for the frame. The frame will be one layer of timbers supported by 1"x2" aluminum posts.
4. The court size will be 12'x60' and the finished surface will be slightly higher than the ground surrounding the court for positive drainage that will drain into our hidden drainage system using 4x4" aluminum for the system.
5. The playing surface will be an NGI synthetic turf surface, with a padded back in the color green, top dressed with in fill sand.
6. We will brush, and groom the court leaving it ready for play. We will also install 4 custom made bocce ball holders and 1 scorekeeper.
8. We will properly dispose of all old materials off site.

Optional:

Client can add standard 4x8 brick pavers in any standard color in stock at a rate of \$9.50 per foot that will include delivery, installation, cuts and waste, and properly disposal offsite. Brick install pattern may require an up charge.

Optional:

Client can add one 8 x 10 shade structure canopy with a green canvas top that will be UV resistant from Sunbrella.
\$9,200 per canopy

A deposit of 50% is required for scheduling and ordering of materials. We will warranty our work for 12 months. We will not be responsible for future substrate surface installation. Pricing is good for 60 days and all signed contracts we will not begin within
